



Executive Director's Report for April 2013

It is with sad heart and deep regret that Commissioner John Konstantinos passed away March 14, 2013. As a member he was truly a leader and champion for the Athletic Commission. Through John's leadership and past and current members of the entire Athletic Commission, Ohio has become a leader and one of the most respected Athletic Commissions in the USA. Continue to remember John's wife Sandi and his daughter Alexis and son Chris in your prayers. May he rest in peace.

The state Super Middleweight title fight will take place in Toledo on April 27th. The title bout will be contested by 2 undefeated fighters Masedonio Molina 7-0 from Toledo and Lane Staal 9-0 from Lansing, MI. Someone's "0" will go!!

I will be testifying at our budget hearing at the Senate on April 24th. With the budget cuts there are still some issues that the Senate must address. With the progress and positive results that the commission has accomplished I believe our budget proposals should be OK.

Michigan Amateur MMA Fighter dies. This terrible tragedy took place in Port Huron, MI. There wasn't any regulation of this event. No Medicals, no pre-fight physical; no ringside physician, no records check in database, no supervision for weight class, etc. These were the some of the reasons Ohio banned Amateur Michigan fighters from competing in our state since March of 2012. This fighter was 35 yrs old, had no documented MMA experience and was living in Canada with a student visa from Nigeria. A state Representative from Michigan has filed emergency legislation and has used Ohio's regulations as a base.

A copy of the email that was sent to promoters and inspectors that you should've received is enclosed. This details the new rule change where they will be contributing a fee to the drug testing. Most states already had a rule like this in effect.

PROMOTERS:

There are some important issues and policies that I want to update you on: Starting in June for any drug tests given to any fighter at an event, a **fee of \$50 for each amateur bout tested and a fee of \$100 for each professional bout tested will be assessed to the promoter. This is a per bout fee and not per fighter fee.**

Pre-fight bout approvals for MMA events: Any fighter that currently has an existing record and DOES NOT have a National ID NUMBER **WILL NOT BE APPROVED until they can show proof they have a National ID.**

This does not apply to any debut fighters. They may get their National ID at the event in which they are competing.

Professional Boxers MUST have a FEDERAL ID number before final approval of their bout at the commission meeting.

PLEASE INFORM all fighters, seconds and trainers who need to get licensed at the event to please follow the below instruction so as to expedite the time for the licensing procedure at an event. It is very hectic at the event with medicals, licensing and weigh-ins occurring. To help make this process go more quickly and more orderly we ask that the below instructions be given to those applying for licenses at the event.

1. Please have them download the proper license form they will need to fill out from the OAC website www.aco.ohio.gov. Most of these forms can be typed in online and then printed or they can download the form and **fill it out prior to coming to the event.** This will aid in having a complete and more legible form with ALL required information.
2. Inform them to have the correct fee for whatever license they are getting (\$20 for ID and \$30 for licenses).
3. The Inspectors will start issue licenses to those who have complied with the above information first. Those that get the forms at the event and fill them out at the event will wait until those that have the completed forms are taken care of first. Again this applies to trainers and seconds, so make sure fighters let them know of these required procedures.

A step by step instruction sheet for those getting their blood tests done through Request-A-Test – phone (1-888-732-2348) so as to follow-up and have access to their blood work through a PDF file online. This is a protected file system that the fighter and commission MUST have a password to get in and view this information. This is not an endorsement of any particular lab for blood work this is information that those getting their blood work done through Request-A-Test apparently are not aware of. By having a PDF file available the test can be printed by any authorized commission or the fighter.
